TERMS & CONDITIONS

For Year 8 students applying for a Harding Miller Education Foundation Scholarship

INTRODUCTION

IMPORTANT – PLEASE READ CAREFULLY

These Terms and Conditions govern your participation in the Harding Miller Education Foundation Scholarship Program. By signing this document, you acknowledge that you have **read, understood** and **agree to comply** with all the terms and conditions outlined below. Please note, since you are under 18 years of age, your **parent or guardian** must also **read, understand** and **consent** to these Terms and Conditions, and must sign this document as well.

ACCEPTING YOUR SCHOLARSHIP

To accept the scholarship, you must complete your **Commencement Survey**, sign this document, and return it as instructed. If you do not wish to accept the scholarship, you must notify Harding Miller Education Foundation immediately in writing via email (info@hardingmiller.org.au).

By accepting the scholarship, you consent to Harding Miller sharing relevant scholarship information with your school, parent or guardian, donors, suppliers, and partner organisations as necessary for the administration of your scholarship.

UPDATING HARDING MILLER

Each academic year, for the duration of your scholarship, you will be asked to complete an online annual survey which will include uploading a copy of your most recent academic results. It is the responsibility of the scholarship recipient to provide this report to Harding Miller by the specified time. Failure to complete the annual survey by the specified time may result in the cancellation of the scholarship.

You must also notify Harding Miller as soon as possible if your circumstances change in a way that may affect your eligibility for the scholarship.

ELIGIBILITY REQUIREMENTS

All scholarships are awarded on the basis that you will maintain an enrolment at a public high school in Australia. Your scholarship will be terminated if your

enrolment status changes, for example if you withdraw from school, transfer to a non-government school or move overseas.

To retain your scholarship, you must:

- Adhere to the academic and administrative policies of the school and/or education institution at which you are enrolled
- Meet any additional criteria outlined in your email notification
- Provide confirmation of your circumstances during the term of the scholarship if requested by Harding Miller
- Actively participate in the program and make use of the tools and resources provided; and
- Adhere to the program guidelines when connecting with your coach.

SCHOLARSHIP TERMINATION

Harding Miller may terminate your scholarship if you have:

- Withdrawn from your government school or approved course of study or have an inactive enrolment
- Failed to meet the eligibility requirements of your scholarship
- Failed to meet the scholarship's Terms and Conditions
- Failed to maintain satisfactory academic progress
- Failed to maintain satisfactory school attendance
- Been suspended or excluded from school or your course of study
- Received an incorrect scholarship offer as determined by Harding Miller at its sole discretion; and/or
- Provided incorrect, false or misleading information or withheld relevant information on your scholarship application or after receiving a scholarship offer.

If your scholarship is terminated prior to you completing Year 12, you will be **required to return your laptop and you will not receive any further broadband**, helpdesk support or tutoring and your pre-paid card will be cancelled.

PREPAID CARD

At the beginning of your scholarship, you will receive a digital prepaid card, which will be topped up with funds each year after completing your Annual Survey. All funds on this card are to be used strictly for educational and school-related expenses. Please refer to the scholar handbook for a list of acceptable purchases. By accepting this scholarship, recipients acknowledge and agree that the funds will not be used for any non-educational purposes. If any of the funds are used for purposes outside the approved educational scope, the recipient may be required to reimburse the Foundation. If you are ever unsure of something you want to use the funds on, please ensure to contact the Foundation via email

TECHNICAL EQUIPMENT

If you have nominated to receive a Harding Miller Education Foundation high-quality laptop and protective case, **you are required to take reasonable care of your laptop. Harding Miller does not offer any warranty period and accepts no liability for any loss or damage of the equipment. You may be required to cover the cost of repairs or replacement of equipment where repairs are deemed not to have occurred through reasonable/normal use.**

PUBLICITY & PROMOTION

If you accept the scholarship and have signed the *Media Consent form*, your details including name, school, photograph, video and scholarship awarded may be passed on to media and used by Harding Miller and organisations that we work with for promotional purposes, including but not limited to Harding Miller's website, social media channels, print/electronic media and reports. If you do not wish for your details to be passed on to media or used for promotional purposes, you must notify Harding Miller in writing.

If you attend events held by Harding Miller or organisations that we work with photos and videos of you at the event (along with your first name, school and scholarship details) may be used for promotional purposes by Harding Miller and organisations that we work with, including but not limited to Harding Miller's website, social media channels, print/electronic media and reports.

Scholarship recipients waive the right to inspect or approve the finished product, the promotional copy or other matter that may be used in connection with it or the use to which it may be applied. If you do not wish photographs and videos of you to be used in this way, you must notify Harding Miller in writing.

LIABILITY WAIVER

In accepting the scholarship from Harding Miller, you agree to WAIVE, RELEASE, AND DISCHARGE Harding Miller, its officers, associates and partner organisations from any and all liability, including but not limited to, any liability arising from the negligence or fault of the entities or persons released, for death, disability, personal injury, property damage, property theft, or actions of any kind which may occur to you during or after the scholarship period, including during or after any travel undertaken as part of the scholarship.



KEEPING YOUR DETAILS UP TO DATE

All correspondence during the application process will be sent to the applicant's personal email address submitted in the scholarship application form. Your principal will also be notified of the outcome of your application. It is also the responsibility of the scholarship recipient to inform Harding Miller if you change your place of schooling, or any personal contact details, during the course of your scholarship.

It is your responsibility to notify Harding Miller immediately if your:

- email address
- phone number
- residential or postal address
- school

Changes at any time during your scholarship. All communication will be sent to the email provided in your application.

PARENTAL CONSENT

Harding Miller reserves the right to amend these Terms and Conditions for commencing and continuing scholarship holders.

Since you are under 18 years old, your parent or guardian must:

- Read these Terms and Conditions
- Understand them
- Consent on your behalf
- Sign this document

Harding Miller reserves the right to amend these Terms and Conditions at any time for both new and continuing scholarship recipients.
